issues can be considered as well. dates are October 28-30 and Governor Pritzker issued total vetoes on seven bills and an amendatory veto on one bill. ISACo will be looking after county interests during the Veto Session.

White House Conference

ISACo joined county officials from Illinois, Indiana, Minnesota and Wisconsin at a White House Conference for local government leaders on Tuesday, August 20, 2019.

The event offered Illinois county officials a unique opportunity to hear from administration officials about a myriad of topics including economic development, opportunity zones, trade, broadband, cybersecurity, disaster mitigation and recovery and other issues of importance to local governments and local economies.

Vice President Mike Pence made a surprise appearance and discussed policy issues with attendees.

Earlier that morning, several Illinois county officials attended a federal issues briefing and breakfast hosted by the National Association of Counties (NACo). Illinois county officials were invited to the briefing by ISACo. NACo Executive Director Matt Chase and his staff discussed issues being worked on by NACo and previewed topics likely to be raised by White House officials.

Large County Board Caucus

Update

ISACo's Large County Board Caucus (LCBC) met on Friday, August 16, 2019, in the DuPage County Administrative Building in Wheaton, Illinois. The Caucus convenes on a quarterly basis but can meet more frequently if necessary. The LCBC consists of counties with 100,000 or more residents.

During the meeting, the LCBC adopted the Caucus' By-Laws, received a report on actions taken by the Governor on legislation of interest to counties, discussed next steps toward addressing the unwillingness of the Illinois Municipal Retirement Fund (IMRF) Board of Trustees to reconsider an actuarial change that would prevent increased costs to local governments and their taxpayers, approved Caucus support for already introduced legislation allowing county boards in counties with 275,000 or fewer residents to locally define the scope of county auditor duties and offered proposals for consideration by ISACo's Legislative Committee for possible inclusion within ISACo's 2020 Legislative Agenda.

ISACo's By-Laws establish three different caucuses to enhance the involvement of counties within ISACo and to ensure that counties of varying sizes have a forum where their issues can be addressed. ISACo Caucuses also benefit from their own lobbyists. In addition to the LCBC, there is a Cook and Collar County Caucus (CCCC) and a Rural Action Caucus (RAC).


On August 26, 2019, the U.S. Census Bureau released the 2020 Census Toolkit for State and Local Officials. The toolkit provides local leaders with resources to help increase response rates to the Census, create public advertising campaigns, access "hard to count" communities and respond to constituent inquiries.

With \$900 billion in annual federal funding directed by decennial census results, an accurate and complete count is crucial to ensure that federal support for counties reflects the

full population of each jurisdiction. Counties are encouraged to take steps to prepare for the Census by organizing outreach efforts and utilizing resources like the toolkit to ensure an accurate count.

Counties Count!

Counties invest over \$554 billion annually and employ more than 3.6 million with more than 19,000 elected county board members and elected county executives.

Health



Counties invest **\$83 billion** for community health and hospitals annually supporting over **900** hospitals and more than **100,000** hospital beds.

Justice and Public Safety



Counties invest **\$93 billion** in justice and public safety services, spending almost **\$26 billion** on correctional facilities. Counties invest **\$35 billion** on **3,041** police and sheriff departments. Counties operate **91%** of all local jails.

Economic Development



Counties invest \$11 billion for housing and community development and almost \$18 billion on parks and recreation facilities, libraries and community centers.

Transportation and Infrastructure



Counties build and maintain 46% of America's road miles and more than 38% of bridges.
Counties own or support 34% of public airports and 78% of public transit systems. Counties annually invest more than \$122 billion total in building infrastructure and maintaining and operating public works and almost \$22 billion in sewage and solid waste management.
